

**Council Resolution 03 (CR03):
Developing and Implementing a One-Card Campus ID
System**



WHEREAS the University of California - San Diego (UC-San Diego) ID card system is fragmented between several entities on campus, in which Housing, Dining, and Hospitality (HDH) uses the Blackboard student card solution, University Centers (UCEN) uses the CCURE 9000 by Tyco system, UC-San Diego Health Sciences uses the HID, and various buildings and departments on campus use the Omnilock system,

WHEREAS the Student (Triton) Card system, for undergraduate and graduate students, and the Campus Card system, for faculty and staff, are separated and composed of two different systems,

WHEREAS the 2014 Student Transportation Fee Referendum provides access to the San Diego Metropolitan Transit System (MTS) bus lines in San Diego, and Transportation Services (TS) is currently using a University Pass (UPass) sticker program to allow MTS student access and has not provided a compass card or radio frequency identification (RFID) card system,

WHEREAS the UPass Agreement between MTS and UC-San Diego, demands that UPass ID Cards be implemented in the Fall Quarter of 2015 to replace the UPass Stickers, and the pilot program for UPass compass cards be initiated in Winter Quarter of 2015 with expected implementation of the UPass compass card by Fall Quarter of 2015,

WHEREAS it is in the best interest of students and business operations to develop and implement a single ID card system for all areas on campus, including the UPass program for MTS bus and trolley access,

WHEREAS the HDH's Blackboard student card solution is the most developed on campus today,

WHEREAS the One-Card Project (OCP) committee has been formed to develop and execute a plan for a single ID card system for all entities on campus, including an RFID student ID card for the UPass, composed of Mark Cunningham (Assistant Vice Chancellor of HDH), Dave Rose (Chief of Police), Todd Berven (Associate Director of Transportation Services), Marisela Garcia-Centeno (Director of Student Business Services), and Min Yao (Assistant Vice Chancellor of and Chief Information Officer of Administrative Computing & Telecommunications),

BE IT RESOLVED that, at minimum, one undergraduate and one graduate student representative, appointed by the Associated Students Vice President of Campus Affairs and

the Graduate Student Association Vice President of Student and Campus Affairs, respectively, is present at all OCP committee meetings to provide student input,

BE IT FURTHER RESOLVED that the committee recommends that HDH's Blackboard student card solution is used as a model for expansion to other areas, including but not limited to libraries, the bookstore, Price Center, Old Student Center, and various buildings on campus,

BE IT FURTHER RESOLVED that the committee works to develop the same one-card ID system for students, staff, and faculty,

BE IT FURTHER RESOLVED that MTS and TS begin to integrate HDH's Blackboard student card solution with the UPass system, and if are unable to develop the system by Fall Quarter of 2015, implement the compass card UPass system as a stopgap until the necessary technology is developed,

BE IT FURTHER RESOLVED that the student representatives communicate to the Associated Students and Graduate Student Association councils on the actions being taken to implement the one-card system, as well as to the advisory boards that oversee the affected entities, including but not limited to the Library Committee (LC), Bookstore Advisory Committee (BAC), University Centers Advisory Board (UCAB), and Transportation Policy Committee (TPC),

BE IT FURTHER RESOLVED that the OCP develops a proposed timeline for the complete implementation of a one-card ID system that is integrated with the UPass, beginning in Fall Quarter of 2015 and concluding by Spring Quarter of 2018,

BE IT FINALLY RESOLVED that the OCP committee presents to the GSA council by the conclusion of the Spring Quarter of 2015 on the proposal, timeline, and budgetary information associated with this project, and receives input from council on changes to make to the proposal by the start of the proposal timeline in Fall Quarter of 2015.
